Re: Complaint about Fiona Seaton - review request

I refer to and thank you for your letter of 16th October 2017, which I received in today's post.

Before you make any decision in relation to my request for a review of the Law Society's decision to summarily dismiss my complaint about Fiona Seaton, can you please provide to me any documents or evidence you have to hand which demonstrate:

1. that I partook in criminal conduct by using Turner Freeman's E-mail system to send an E-mail to Ms Roseanne Beckett in the name of Terence Goldberg;
2. that I am a dangerous individual;
3. that I have a documented history of violence;
4. that I was ejected for misconduct (including violent conduct) from an incorporated association whose membership consisted mainly of elderly women;
5. that I physically assaulted an elderly committee member of that association;
6. that I directed others to perpetuate an act of violence on an 83 year old clergywoman who walked with the aid of a stick;
7. that I sought control of the same association's assets for my own benefit;
8. that I admitted the above as countenanced in paragraphs 2 to 7 during the pendency of Supreme Court proceedings;
9. that I consistently and persistently stalked Terence Goldberg of Turner Freeman Lawyers;
10. that I attacked Terence Goldberg in Martin Place;
11. that I harassed Terence Goldberg while he was out on a weekend with a family member;
12. that I sent numerous anonymous E-mails to members of staff at Turner Freeman; and
13. that I make the acquaintance of elderly women in order to benefit from their assets.

As you are aware, the above is a summary of the accusations levelled at me by Fiona Seaton in her letter to DG Thompson Lawyers of 17th February 2017, which provoked my complaint to your office, and also in her subsequent letters to the Law Society.

In relation to paragraphs 9 to 12 listed above, and before you take care to allude to the private apprehended violence order proceedings as instigated by Terence Goldberg and heard in the Local Court Sydney on 26th February 2016, you will note from the transcript already provided to you that there is no mention of any violent behaviour on my part toward any person, nor any mention of the contents of the above paragraphs 9 to 12.


It seems that the main thrust of Terence Goldberg's private application to the Court regarding the above was to discover the identity of the author or authors of the website <http://www.terencegoldberg.com>, which, incidentally, precisely details an act of fraud as perpetrated by Mr Goldberg. The author or authors of this site remain publicly unknown.

Such site remains intact and online, and describes minutely not only the wrongdoing carried out by Mr Goldberg (with such site including copies of Court documentation proving such wrongdoing), but also how funds belonging to an incorporated association have improperly made their way to the home address of Miranda McCarthy and Jon Lindsay, with both of those persons being long-time acquaintances of Terence Goldberg.

Due to my concerns about your own conduct in relation to this and other matters, and due to my strongly held belief that you are partaking in corrupt activity, a copy of this letter shall be provided to the Independent Commission Against Corruption.

I look forward to your swift response providing copies of the requested documentation.
